10.11.24 Planning 24/00823/DEM – Removal of 2 TV Masts. BBC Transmitting Station, Wallsworth Hall, Sandhurst Lane. No comments made.

11.11.24 Standing Items Village Green / Recreation Ground. Build Back Better Scheme Grant £4,021. JS gave an update, Agreed to write an application for the Enovert Community Trust, we are eligible as we are close enough to a landfill site that they operate. I've spoken to the grant manager and we have a fair chance, but we need to get on as the application needs to be in by 30/11 so that it is reviewed in their meeting at the end of Jan. I will draft the application ASAP (With help from the Clerk on account details etc) and need to get more quotes for the work as they need to see evidence that the prices are competitive. We agreed that the scope should be replacement of the MUGA ends (the football + basketball frames at the ends of the existing court), relocation and refurbishment of a few seats/tables, resurfacing of the rubber areas and the addition of a climbing structure to suit older children. We noted that if we are successful we would need to be careful with sequencing the work to reflect the fact that we would be paying VAT then claiming it back, however there are loans available that may help covering this.
